## **BUYING TERMS AND CONDITIONS**

### **EXPORT SALES**

- All Export Sales are based upon minimum purchase levels and supplied on an Ex-Works Port Klang Free Zone price in US\$.
- Orders can be placed directly with KLF Fashions online through the website.
- All Clients who register and order online will receive email confirmation of each order placed, including an on-going history of purchases.
- KLF Fashions will generate Pro-forma Invoices for approval inclusive of payment terms, delivery confirmation dates, payment and terms and conditions of supply.
- All products come with a warranty period which varies according to product type.
- All Jewellery items meet the UK Content Regulations and are compliant to both the UK and US regulatory standards for hazardous materials.
- KLF can provide a Certificate of Origin from Malaysia if required.
- KLF can also provide Logistic Support for the Shipment and Dispatch of Goods at competitive rates.
- KLF can arrange all required exportation documents in accordance to Client's needs.
- Normal Terms of Payment:-
  - 30% against a confirmed Pro-forma Invoice**
  - 70% against Goods Dispatch Documents**
- If required KLF can customise packaging, provide an OEM Product or manufacture according to specific design requirements and quality.
- All payments will be made into a nominated KLF banks account, the details of which will be identified on each Pro-forma Invoice.
- Final Billing will be made upon completion of each order and prior to dispatch of goods.
- Samples of product can be sent prior to dispatch of goods for approval and inspection, the cost of which including Courier Charges will be borne by the buyer.
- Normal supply capability is 10 to 14 days from the date of a confirmed order. Out of stock items will be carried forward to the next order and appropriate delivery.
